DR. WALTER SHEPHERD BARGE - Emeritus Professor of History at Campbell University, died Sunday, June 7, 2009, at his home in Buies Creek, North Carolina after a brief illness. He was 74 years old. The cause of death is unknown. He was preceded in death by his parents, Thomas Henry Barge and Mary Lake Barge, of Durham; and brother, Beverly Lake Barge. Born in Durham, North Carolina on December 14, 1934, Dr. Barge pursued a professional life of both academics and military service. He began his education in the Durham city schools system. In June 1957 he earned his BA in history from Wake Forest College, at which time he was commissioned as a Second Lieutenant in the United States Army. During the next two decades, Dr. Barge proudly served his country, including tours in Korea and Vietnam. When Dr. Barge retired from the Army with the rank of Lieutenant Colonel in 1979, he was awarded the Legion of Merit for his exemplary military career. He was a Life Member of Vietnam Veterans of America – West End Chapter #966. His commitment to academics is equally laudable. In 1965, after being selected by the Army to pursue graduate studies, he received his MA in European history from Columbia University. In 1982, he completed his PhD at the University of North Carolina-Chapel Hill. After a total of nine years teaching in the History Department of the United States Military Academy in West Point, NY, Dr. Barge continued his academic service in civilian life, most notably as Dean of the College of Arts and Sciences at Campbell University. He created Campbell's Academic Honors Program, which recently recognized him by establishing the Walter S. Barge Honors Colloquium student lecture series. During 25 years at Campbell University, he also served on the history faculty and the honors faculty. Dr. Barge's love for teaching and his devotion to his students kept him in the classroom (the last six years as an adjunct professor) until shortly before his death. Walter S. Barge will be remembered for his commitment to fostering academic excellence through integrating faith and learning in the classroom, for patriotic service to his country, for his devotion to his family, and for his Christian faith. A memorial service, officiated by the Reverend Denton White, will be held at Grace Community Church, 2160 Harnett Central Road in Angier, on Saturday, June 13, 2009 at 11:00 a.m. Survivors include his wife of 52 years, Sarah Barclay Patterson, a native of Wake Forest; three sons, their wives; and five grandchildren. DONAT "Don" GOUIN - Died Wednesday, July 15, 2009 in Lima, Ohio at the age of 80. The cause of death is unknown. Family members describe Donat "Don" Gouin as a man of God, country and family. They believe it's what brought the Vietnam prisoner of war home to them. "I honestly believe that his faith in these three things is what got him through his experience in North Vietnam," said Barbara Sutton, daughter of Gouin, who died Wednesday. "He never gave up — knowing that his God, his family and his country would not let him down and would be there for him no matter what," she continued. Gouin, who retired as a Master Sergeant (E-8) from the United States Army after 27 years. Gouin was captured Feb. 3, 1968, by the Viet Cong in the attack on the city of Hue. He was released March 4, 1973. He told The Lima News after his return that he never gave up hope of returning and never at anytime doubted that he would survive. Sutton recalled that her mother, Alma, never hinted to her or her siblings that their father might not come home. Every prayer included the words "Please watch over Daddy." He received a hero's welcome, including a key to the city, when returning to Lima. Jack and Wilma Laeufer, of the Lima Area Missing In Action-Prisoners of Wars group, met Gouin after his return. The couple has a cousin still missing in action from 1970. Jack Laeufer and Gouin often talked at school and churches together. "He was helping us get the word out that we still have men missing in South East Asia," Jack Laeufer said. "He was a man I would stand up beside in any conflict. He was just likable." Gouin's commitment to other POWs was evident. He declined comment on his imprisonment right after being released "because I don't want to do anything that might jeopardize the release of those still held." "Time in captivity should be remembered and honored," Wilma Laeufer said. "They were years that were taken away from them. Don was a special, special guy." While in the Army he received the Good Conduct Medal, two Purple Hearts, a Meritorious Commendation, the Vietnam Commendation Medal, the National Defense Service Medal, the Prisoner of War Medal, the Bronze Star and the Silver Star. He was a Life Member of Vietnam Veterans of America – Lima Chapter #89. Gouin is also remembered as a family man, who taught his children to have faith in Jesus. He was happiest spending time with or talking about his eight grandchildren. A Mass of Christian Burial will begin at 10 a.m. Monday at St. Gerard Catholic Church. Friends may call from 3 to 7 p.m. Sunday at Chiles-Laman Funeral Homes, Lewis Eastside Chapel.
