MEMORANDUM FOR RECORD:

On April 21, 2022, during the Conference of State Council Presidents, the Secretary unexpectantly resigned and left the Conference. The Chair requested the First Vice to take over keeping minutes for the Conference. The First Vice immediately moved to censure the Chair. The Parliamentarian ruled that since the First Vice was the moving party, the Second Vice had to manage the Motion. The motion was discussed, a vote was taken and the motion failed. The Chair than recessed the meeting for lunch. The Chair then appointed Chuck Odom (State Council President for Mississippi), as pro tem Secretary and he agreed to act for the duration of the meeting. No one objected.

John McGinty, Second Vice Chair (CSCP).

Call to order by Chair Sam Brick at 1:25pm. Chuck Odom, Mississippi State Council President appointed secretary for this afternoon meeting only. Discussion ensued regarding any proposed MOU between VVA and the entity(s) VVoA (Vietnam Volunteers of America) or any subsequent entity. The language in that MOU must be written in such a manner that protects and inures the corporation from harm created by the transfer of the claimants P.O.A. (Powers of Attorney) to the VVoA should the VVA cease to exist in its current form.

<u>Dr. Wayne Reynolds</u> asked if the officers of the VVoA would stay in place if the POAs resided in the VVA. Reasoning that the VVoA would be experienced and familiar with the VVA way of handling these claims thereby avoiding a steep learning curve.

<u>Sam Brick proposed</u> moving this question to a committee to discuss, <u>seconded by G.</u>

Gomez.

Comment: <u>John McGinty to John Margowski</u> – consider on Saturday at VVA BOD Meeting.

<u>Dennis Howland</u>: Asked What is the purpose of Committee? "To get a consensus of the CSCP on the question of who handles claims."

<u>Mark McCabe</u> was asked to respond by <u>Chair Brick:</u> McCabe stated the intent was to anticipate long-range handling of Board of Appeals claims for spouses and children, Representation thru the appeal resolution. Veterans Benefit Committee to discuss as they anticipate to be around after VVA dissolves. Possibly overseeing work processes.

VVA VSO accreditation advanced training, three months to complete training.

Sam Brick: Any questions for Mark McCabe?

Wayne Reynolds – Please identify members of the VVoA when available Claire Coursey (Chief Counsel for VSO program) Has 6 attorneys on staff, Explained process for POA clients. VVA sets a high bar and expectations for claims handling.

<u>Sam Brick</u>: Where would funding come from? <u>Claire</u>: Self-funding thru donations,

<u>Charlie Montgomery</u>: Process for VVA shedding of POAs? Answered by Mark and Claire. (Signed Letter of revocation by the claimant/ Under no circumstances could the POA be reassigned without the knowledge and consent of Claimant).

<u>Puerto Rico</u>: Brief discussion re: Widows and Children's benefits are slow to resolution need quicker responses from VA. Veterans day meeting including Clinic Visits were a big success and greatly appreciated. Participants felt uplifted and inclusive.

<u>G. Gomez</u>: 10 VSOs for Massachusetts. President of State Council responsible for ensuring smooth operation and oversight.

Discussion of Suspension list and resolving their issues.

<u>Dick Southern</u>: Discussed the one-time waivers for those chapters in suspension for the purpose of attending the National conference/ Data Base issues/ There were some errors
