

Hello Everyone, and welcome to the February 2023 edition of our Regulatory and Governmental Affairs newsletter.

Rules and Proposed Rules

Persons Eligible for Burial. This proposed rule by the Department of Veterans Affairs regulations would revise current implement Section 6601 of the 2022 National Defense Authorization Act, which would expand burial eligibility to include honorably discharged members of special guerrilla units or irregular forces operating from a base in Laos in support of the military between February 28, 1961 and May 7, 1975 and who was an American citizen or lawful alien, and who resided in the United States when they died. Comments on the proposed rule can be submitted via www.regulations.gov and must be submitted no later than April 17, 2023.

Reconsideration of Prior Interment and Memorialization Decisions.This proposed rule would amend existing VA regulations to allow VA the authority to reconsider prior decisions to inter or honor the memory of a person in a VA national cemetery. Specifically, the regulatory

change would implement review criteria and procedures for considering the internment or memorialization of individuals charged with or convicted for federal or state capital or tier III sex crimes. Comments on the proposed rule can be submitted via www.regulations.gov and must be submitted no later than April 28, 2023.

Reimbursement for **Emergency Treatment.** The VA is finalizing an interim final rule amending regulations regarding payment or reimbursement for emergency treatment of non-service-connected conditions at non-VA facilities. This version also addresses VA's regulations authorizing payment/reimbursement of coinsurance, waiver of timely filing requirements for veterans affected by the interim final rule, and authorizes payment or reimbursement for emergency transportation associated with emergency treatment where the VA has paid for emergency treatment using a separate authority. These changes were not addressed in the Supplementary Information section of the interim final rule, so VA is offering this announcement as an opportunity to comment on the changes. Comments can submitted be www.regulations.gov and must be submitted no later than April 24, 2023.

Bar to Approval for Education. This proposed rule would implement a provision of the Veterans Benefits and Transition Act of 2018, which requires a State Approving Agency or the Secretary of the VA to disapprove education programs provided by institutions that don't allow individuals using VA benefits to attend or participate in coursework while the institution awaits VA

payments, or where the institution imposes penalties on a student resulting from delayed VA payments. This proposed rule would also allow educational institutions to require VA educational beneficiaries to submit certain documents and would clarify that educational institutions may require beneficiaries to pay certain charges or fees if VA delays payment and ultimately pays less than what an educational institution anticipated receiving. Comments on the proposed rule can be submitted www.regulations.gov and he must submitted no later than April 28, 2023.

Dependency and Indemnity Compensation Cost of Living Adjustments. On February 3, 2023, the VA gave notice of an increase to Cost-of-Living Adjustments that affect the Dependency and Indemnity Compensation (DIC) program. Effective December 1, 2022, the COLA was increased 8.7%.
