

# Legislative & Regulatory Updates Newsletter November 2023

# New Rules

**Final Rule - Presumptive Connection for Cancers due to exposure to Fine Particulate Matter.** This rule, which took effect on November 3, applies to two categories of veterans suffering from specific cancers. The first are those who served in the Persian Gulf War (August 2, 1990, or later). The second are those who served in the Southwest Asia theater of operations, Afghanistan, Syria, Djibouti, or Uzbekistan during certain periods. The presumptive illnesses covered include:

- SCC of the larynx or trachea;
- Adenocarcinoma of the trachea;
- Salivary gland-type tumors of the trachea or lung;
- Adenosquamous carcinoma of the lung;
- Large cell carcinoma of the lung;
- Sarcomatoid carcinoma of the lung; and
- Typical and atypical carcinoid of the lung.

**Final Rule - VA Pilot Program on Graduate Medical Education and Residency (PPGME).** This rule, which takes effect December 13, 2023, will institute the PPGME, allowing the VA to assess alternative methods for funding residents outside of the VA's current graduate medical education structure. Specifically, the VA will place residents in covered facilities, prioritizing placement of residents in facilities serving Native Americans (e.g. the Indian Health Service, tribe-operated facilities, etc.).

**Final Rule - Reevaluation of Claims for Dependency and Indemnity Compensation.** Effective January 2024, the VA is implementing Section 204 of the PACT Act, which calls for the reevaluation of claims for dependency and indemnity compensation involving the Act's new presumptions of service connection.

**Final Rule - Payments Under State Home Care Agreements for Nursing Home Care.** This final rulemaking changes the State Home per diem regulation by implementing a new formula for calculating the prevailing rate that the Department of Veterans Affairs (VA) will pay State Homes that agree to provide nursing home care to eligible veterans. VA had been relying on an outdated calculation method from the Center for Medicare and Medicaid Services (CMS). CMS abandoned this method in 2019, but VA has chosen not to adopt CMS's new method. The new formula will reflect the prevailing rate that is payable where State Homes are located for nursing home care furnished in those State Homes. The new formula will apply to both new and existing agreements, and VA will adjust rates annually to reflect changes made by CMS.

**Proposed Rule - Commemorative Plaques and Urns.** The VA is beginning its regulatory process to implement its new authority under the *Isakson and Roe Veterans Health Care and Benefits Improvement Act* to furnish commemorative plaques and urns for qualified veterans whose cremated remains are not interred. Comments on the proposed regulatory change must be received by the VA on or before January 19, 2024, and may be submitted on <u>regulations.gov</u>.
