# Referred to the Senate Veterans Affairs Committee

**S. 3560** Combat Veterans Pre-Enrollment Act of 2024.

- H.R. 7049 Repeals the VA directive relating to the COVID-19 vaccination program for Veterans Health Administration health care personnel.
- H.R. 7091 Requires VA medical facilities to share certain data with State cancer registries.
- H.R. 7100 Clarifies the organization of the VA Office of Survivors Assistance.
- H.R. 7136 Requires the VA Secretary to establish a comprehensive standard for timing between referrals and appointments for care from the VA and to submit a report with respect to that standard.
- H.R. 7150 Directs the VA Secretary to improve equitable access to certain benefits under the laws administered by the VA and to improve certain outreach to individuals who served uniformed services and dependents of such individuals.
- H.R. 7154 Renames the VA community-based outpatient clinic in Butte, Montana, the "Charlie Dowd VA Clinic".
